Requesting Your Medical Records

Patients have the right to request copies of their medical records.

To obtain a copy of your records, please follow these steps:

1. Complete and sign a Medical Records Request Authorization Form.
2. Submit the completed form to our office by:

7. Include a copy of a valid government-issued photo identification.
8. Specify whether you would like your records sent electronically, by mail, or made available for pickup.
9. Allow sufficient time for processing as permitted by applicable federal and state law.

If you believe your protected health information has been improperly used, disclosed, or handled, you may file a complaint with our office and/or with the Texas Attorney General.

Filing a Consumer Complaint with the Texas Attorney General

If you believe your medical privacy rights have been violated, you may file a complaint with the Texas Attorney General.

Steps to File a Complaint:

1. Visit the Texas Attorney General Consumer Protection Division website.
2. Complete the online complaint form or download a complaint form for submission.
3. Provide all requested information and supporting documentation.
4. Submit the complaint according to the instructions provided by the Attorney General's Office.
